

BARTON PARISH COUNCIL MEETING MINUTES

105 Correspondence	105.1) Wells Green Walkway – dangerous wall reported by a concerned Parishioner. Owner of the property alerted and the tree that was knocking the wall down has been removed. Wall being repaired by stone mason. Cllr Wool noted that if such emergencies arise that are PC responsibility, Billy Darkins is a good contact to consider
106 Public Participation	Ms Marwood discussed the need for a footpath up Church Lane. From the Church to the houses there is no footpath on either side of the road and it is potentially dangerous for pedestrians and horse riders. Cllr Wool explained it is NYC Highways department that would be responsible for a footpath and that Cllr Thompson maybe able to assist. Cllr Thompson details passed on. Cllr Dobinson suggested an angled mirror to help with visibility but Mr Walsh explained there would not be enough of an angel for the mirror to be effective
107 Planning	To consider the planning applications within Barton Parish None submitted in the previous month
108 Police & Crime Update	108.1) To review Crime Bulletin for the Parish June 9 crimes: 5 x Violence against a person, 3 x arson & criminal damage, 1 x drug offences. The Police Report is now being circulated via the Village Network email 108.2) Update on vandalised car at Beck Bridge- car has been removed. Prior to it being removed NYC visited the site and stated that the car was not causing an obstruction or parked illegally.

PCSO Gayle Smith attended the meeting. Going through the Crime Report it was explained that 'Violence against a person' can be domestic and could range from an argument to a physical act – it is not always a physically violent act.

The crimes on the report can either be a crime committed in Barton or by someone who resides in Barton. PCSO Smith explained she has delivered some lessons at Barton Primary School on cyber safety – it is a big issue everywhere so trying to get message across to children to be cautious.

Cllr Wool explained that Sept – Nov last year there were a lot of problems with older youths in and around the playground and lots of broken glass was being left. PCSO Smith said that she can increase the patrols in the area if this continues to happen.

Cllr Wool highlighted that cold callers are still entering the village despite it being a Cold Caller zone. There are vulnerable residents in Barton – Cllr Wool asked if there was a way that we could catch-up with the vehicles that are dropping the cold callers off. PCSO Smith said that if the registration of the car dropping them off is taken down, give NYP a call and they will be able to put a marker on the car. NYP had successfully dispersed a group of four in the Dales who were carrying out cold calling by having the vehicle details – this helped NYP track them down.

Chair Jones spoke of the spate of burglaries in July along with the allotment shed being broken into and two pieces of equipment being stolen. Cllr Dobinson suggested that the Mardis Club held every Tuesday could be a good platform, with over 30 pensioners attending for NYP to speak at. PCSO Smith agreed and said that she could get the Fraud Squad involved and that they have a 'Coffee with a Cop' scheme - where parishioners can share a coffee with a police officer and discuss concerns. Cllr Wool also highlighted the coffee morning at St Cuthbert's on a Wednesday morning could be another useful way to get concerns or questions to NYP. PCSO Smith to liaise with Mardis Club and St Cuthbert's to attend.

Mr Walsh spoke of farming contractors speeding through the Village and Church Lane on tractors with heavy trailers being towed. The Matrix Board is triggered at 34mph and it is constantly going off for the speeding tractor/trailers. PCSO Smith explained if the speeding is logged on 'Road Wise' website and enough complaints are made for a particular area, NYP will come and target the area to monitor speeding.
